From the Director's Desk

2021 was a year of tremendous change as the COVID-19 pandemic and global response evolved. Addressing racism as a structural disparity within public health remains as urgent as ever. At the California Prevention Training Center (CAPTC) we stayed responsive while always pursuing our mission to promote health equity.

Our Disease Intervention Training Center launched new leadership and learning collaboratives designed to address issues core to our participants' requests, such as trauma-informed approaches to contact tracing. Simultaneously, we are looking ahead to longer-term goals, including a return to sexual health-centric offerings by the end of 2022.

Our deep partnership with the California Department of Public Health (CDPH) further enhanced trainees' critical disease intervention skills through blended virtual learning opportunities.

Both our STI Clinical Training and Family Planning teams stewarded their audiences through longawaited recommendations and policy changes from the CDC and California Department of Health Care Services Office of Family Planning. The Clinical team saw a renewed focus on STIs and increasing urgency to address disparities in PrEP access. The Family Planning team focused on training providers to deliver family planning services through telehealth and address vaccination concerns during the COVID-19 pandemic.

Confronting core structural issues of the national healthcare crisis—which existed long before COVID-19—is a key aspect of the CAPTC's mission. The Capacity Building Assistance group held a series of events for public health workers to address stigma and discrimination.

Our Communications team debuted a refreshed CAPTC website and released Season 2 of our podcast on sexual health, now called *Coming Together for Sexual Health*.

Finally, it was also a year of transition for me. I took on the role of CAPTC director in early 2021, and have been focused on working towards our vision of equity and inclusivity in new, tangible ways, starting with our internal communication and staff engagement. I am determined to continue the great work of the CAPTC that you know so well and hope to discuss how we can better meet your needs for training and capacity building.



Learners increased knowledge and skills by 25% across all CAPTC courses with evaluation data (n=2,334).




Learners work across the sexual health field.



Learner Satisfaction


Across courses, participants expressed the high value of CAPTC course offerings.

Surveys showed:






Overall satisfaction (n=1,183)

National Leadership

In 2021 we guided the disease intervention workforce across the United States through evolutions in the dual crises of COVID-19 and STIs.

The CAPTC's clinical program medical director and principal investigator, Dr. Ina Park, co-authored the long-awaited 2021 CDC Sexually Transmitted Infections Treatment Guidelines which had been delayed by COVID-19. Once published, we held a comprehensive webinar to steer clinical providers through updates.

The CAPTC continues our partnership with Cicatelli Associates, Inc. (CAI), providing virtual trainings on evidence-based interventions in accordance with CDC strategy. These are designed to ensure that the HIV prevention workforce has the competencies and support necessary to accelerate progress toward ending the epidemic.

CAPTC staff supported over 35 trainings during 2021, reaching learners across the country.

Addressing the COVID-19 Pandemic



National / Regional COVID-19 Response

CAPTC, through the National Network of Disease Investigation Training Centers (NNDITC) continued to support learners and develop curricula. These activities are critical to growing a strong public health workforce. NNDITC additionally offered learning collaboratives focused on participant-requested topics. Themes included vaccine hesitancy, trauma-informed care, and managing breakthrough infections. Collaboratives enable peer-to-peer learning across health jurisdictions and improve public health networks.

This year we launched a leadership training track for COVID-19 public health leaders. These three-day trainings support team leads and strengthen their ability to be effective coaches. Through this track, we support managers in promoting culturally-competent, sustainable COVID-19 response activities.



California COVID-19 Response

We continue a strong collaboration with the University of California, San Francisco and Los Angeles (UCSF and UCLA), and the CDPH on the Virtual Training Academy+ (VTA+). VTA+ supports California's evolving public health response to the pandemic. Additional trainings, webinars, and skills-based labs addressed remote working, outbreak management, vaccine communications, school reopening, and more. Support mechanisms such as peer-to-peer learning, mentorship, wellness support, and in-service training were added. We aim to facilitate connection and resilience. In 2021, VTA+ reached over 3,400 learners through virtual skillsbuilding workshops.

Leading the Western States



Enabling Structural-Level Change in the Western Region

We nurtured strategic partnerships that allow us to confront systems-level inequities on a wide scale. With our partners in the Western Region, the CAPTC held a compelling symposium on "Strategies to Address Medical Mistrust." The event highlighted the impact and health effects of medical mistrust in Black, Latin, and Indigenous communities. To support structural interventions, we convened institutes addressing syringe services programs and condom distribution. These gatherings built the capacity of health department and community-based organization staff.

STI Consultations for Providers

The STD Clinical Consultations Network provides clinical decision support to licensed healthcare professionals and STI program staff.

In 2021, we provided 275 consultations to staff at local health departments, community health centers, family planning clinics, and more.

Collaborative Learning Across the West

The CAPTC hosts 76 members in the *Ending the HIV Epidemic Learning Collaborative*. We provide a platform for health departments, community partners, and organizations to network, share experiences, and learn.

We formed the learning collaborative *Social Media Strategies and Social Marketing Campaigns.* This supported health departments in strengthening virtual community engagement efforts during the pandemic. Members explored and drafted media strategies and campaign action plans.

Evidence-Based Interventions

CAPTC collaborated with Kaiser Permanente Northern California (KPNC) to share ideas and best practices for delivering sexual health care virtually.

Five virtual *Sexual Health Learning Community* sessions were held to support KPNC's new appbased specialized sexual health visit. This initiative allows patients to request STI and HIV testing and PrEP without a primary provider consult.

Supporting PrEP and Expanding Networks Locally

Recognizing the unique longitudinal needs of PrEP patients, CAPTC held a series of PrEP institutes in Orange County and San Diego to support providers and clinics in understanding how to provide basic PrEP care and navigation.

The institutes were integral in linking participating clinics with partners in this work, connecting them to a broader best practices network.

Supporting Providers and the Public in California

In collaboration with the CDPH, we expanded the capacity of Local Health Jurisdictions (LHJs) and STD Control Branch frontline providers to support client self-disclosure. We created a blended learning experience that included selfstudy modules and live virtual skills-based practice. Additionally, we established learning collaboratives focusing on stigma and biasreduction exercises for the public health workforce. The goal was to facilitate a greater client-centered approach with clients who identify as men who have sex with men (MSM) and people who use drugs (PWUD).
